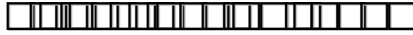


**2024 FLOURTOWN SUMMER DAY CAMP**

**The fee for the CIT program is \$140.00 per week. Please do not send any payment with this application. CIT's will be selected by the end of April. At that time, you will be notified about your acceptance into the program and when payment is due.**

*The CIT program is designed for those campers who have shown a high level of maturity and character, together with a strong interest in working with children.*

*Each CIT will be assigned a group or specialty area of instruction for the duration of their enrollment. We will provide an excellent learning environment, with proper supervision. The CIT's will have a scheduled break in the afternoon schedule for swimming, basketball, etc. Each CIT will be evaluated by their cooperating Senior Counselor, CIT Coordinator and camp administrator. We will meet regularly with each CIT to inform them of their performance and make suggestions if and when necessary.*
