The CIT's will have a scheduled break in the afternoon schedule for swimming, basketball, etc. Each CIT will be evaluated by their cooperating Senior Counselor, CIT Coordinator and camp administrator. We will meet regularly with each CIT to inform them of their performance and make suggestions if and when necessary.
